**1. EVENT TITLE, DATE & VENUE**

1.1 Event Title

**2026 MOTORSPORT AUSTRALIA NSW Motor Race Championship, Round 3.**

This will be a **STATE 1 DAY / NIGHT CIRCUIT RACE EVENT.**

**1.3 Date: SATURDAY 20th June 2026**

**1.4 Venue: Sydney Motor Sport Park, – the 3.9 km Gardner (GP) Circuit will be used.**

**2. ORGANISATION AND STATUS**

2.1 The Event shall be held under the FIA International Sporting Code including Appendices, the National Competition Rules (NCR) of Motorsport Australia, the Circuit Race Standing Regulations (CRSR) published by Motorsport Australia, relevant Championship and/or Series Sporting and Technical Regulations as approved by Motorsport Australia, these Supplementary Regulations, and any Further Regulations and instructions to Competitors that may be issued.

#### 4. MEDICAL

Medical requirements will be in accordance with Article 3.1.4.3 of the Motorsport Australia Medical Service Requirements at Motor Sport Events.

#### 5. CIRCUIT DETAILS

- a) Length: 3.9 km  
b) Direction: Anti - Clockwise  
c) Track Density: The maximum number of starters permitted in any race will be in accordance with Motorsport Australia guidelines.

#### 6. My Laps Race Control Management System

The fitting of a MyLaps unit is now **mandatory** when participating in any track activity at SMSP. It should be made clear that this unit has **NO REGULATORY IMPLICATION** regarding Motorsport Australia. It is a device to assist in the management of the track between Marshal Posts and as an advisory device for the driver.

- The units remain at all times the property of ARDC.
- It is the Competitors responsibility to ensure adequate fitting to the vehicle using the materials provided.
- As this unit for the driver is advisory, there is no requirement as to it being placed in view of the driver, simply a secure place on the vehicle that can transmit a valid signal.
- Should the unit fail to be observed during any session on track, the competitor will be advised post session and steps taken to ensure there is a fully functioning unit attached to the vehicle prior to any subsequent sessions.
- There is **NO** additional charge, for the use of the unit at this Event.
- Unit can be picked up and returned to the Main Office at the base of the Control Tower, which must be done at the beginning and end of each day, to ensure that unit is adequately charged for use.
- There is now available a cable than can be hard wired into the vehicle for the purposes of charging. This can be purchased from ARDC @ SMSP and is a **onetime purchase cost of \$20**. Please contact ARDC for details.
- Should a competitor leave the venue without returning the unit, the safe return of the unit, in full working order, will be at the full expense of the Competitor and must be **received** by ARDC **within a 2-week period**.
- **Failure to return** the unit within the 2-week period or at all, will result in the competitor being invoiced for a replacement unit **(\$1100)**.

**8. EVENTS**

8.1 These races will be held in accordance with the Motorsport Australia Manual and the relevant Sporting & Technical Regulations and appendices for 2026.

8.2 Races will be conducted for vehicles complying with the relevant Sporting & Technical Regulations for the following,

- 2026 NSW Improved Production Championship (47)

- 2026 NSW Production Car Championship (54)

**ENDURO RACES –**

- **2026 RX-8 Cup Series Regulations (54) (4 Races)**

8.3 In order to maximise track time and racing laps for all categories, ARDC in consultation with Motorsport Australia reserve the right to combine events. This will be done with due consideration to the State Championships and the categories concerned. Any such combination will be advised in the Race Event Schedule.

8.4 Qualifying will take place on Saturday 20<sup>th</sup> of JUNE 2026.

8.5 The Organiser reserves the right to postpone, cancel or stop the Event in accordance with the NCR.

**9. LICENCE & MEMBERSHIP REQUIREMENTS**

9.1 Competitors must hold a current Motorsport Australia-Affiliated Sporting Car Club Membership unless they comply with 9.2.1 or 9.2.2 below.

9.2 Each Driver must hold a minimum of a Motorsport Australia Provisional Endorsed Circuit licence, unless noted otherwise against a particular Event or specified otherwise in the Sporting Regulations for the relevant category Championship/Series or;

9.2.1 Hold a Motor Sport New Zealand competition licence and valid Tasman Visa for the event or

9.2.2 Hold the minimum of the highest-grade National Licence issued by a foreign ASN required for the Event and obtain approval to compete from the ASN that issued their licence. Each such Driver and Competitor.

9.2.2.1 Will be ineligible to score points in a Championship/Cup/Series/Trophy etc. connected with the Event unless specified otherwise in category Sporting Regulations : and

9.2.2.2 Shall be required to receive an authorisation to compete from Motorsport Australia prior to the Event.

**10. AWARDS/PRIZES**

Awards for this Event will be in the form of trophies and will be provided by the Organiser.

They will be awarded as per the relevant category Sporting Regulations, approved by Motorsport Australia for 2026, and in conjunction with the 2026 Motorsport Australia NSW Motor Race Championship Sporting Regulations Chapter 3 – Awards and Point Scores. **Round Awards will be presented on the day on the ARDC/SMSP PODIUM, AFTER THE RACE AFTER THEIRS.**

**11. AUTOMATIC TIMING**

The Organisers utilise an automatic timing system that requires all cars to be fitted with a **MYLAPS TR2** Transponder.

Competitors must provide the transponder. Transponders are available for hire during the ARDC Online Entry System process, (\$35 per event), or for purchase from MYLAPS Industries - <https://mylaps.com/motorsports/> or PHONE 02 50057690.

**12. PRIVATE PRACTICE AVAILABILITY**

Sydney Motor Sport Park is available for Private Practice on **Friday 19th of JUNE 2026**. Private Practice times **for this event will go from approximately 1130 – 2200**. Final times TBA but time will be extended into the night. Entry for Private Practice can be made **during** the Online Entry System process, **WHILST ENTRIES ARE OPEN**. The GST inclusive cost is **\$280** per day to members of the **A.R.D.C.**, and **\$340** per day to **Non members**.

Private Practice Entry **can** be made on the day, by filling in the relevant documentation and paying the required 'On the day' Entry Fee. (The cost is **\$340 inc** per day to members of the **A.R.D.C.**, and **\$400 inc per day to Non members**).

### 13. GARAGE AND PADDOCK ALLOCATION

The On-line Entry System allows the **BOOKING & REQUESTING** of Garages and Carports. **ARDC members are given 1st offer of Garages**, ie they can **BOOK** a garage. **Non-members** are only allowed to **REQUEST** a Garage initially. (If you do receive a Garage, it is recommended that you bring your own padlock).

### 14. CREDENTIALS

14.1 Competitors should enter Sydney Motor Sport Park via Gate A off Ferrers Road.

14.2 This event will be a **NON-TICKETED EVENT. NO TICKETS WILL BE ISSUED OR SOLD.**

This may be updated in any Further Supplementary Regulations that may be issued for this Event.

14.3 All Competitors will be given 1 Vehicle Tender Pass for the event.

14.4 All Categories will be given 3 VIP Vehicle Tender Passes passes for Category Management Staff.

#### 14.5 PIT CREW CREDENTIALS

14.5.1 Pit Lane wristband passes can be issued at Friday practice and will be valid all weekend.

All Pit Crew **MUST** wear their wristbands at **ALL** times while in a **RESTRICTED AREA, ie, PIT LANE, MARSHALLING AREA.**

**All** persons **NOT** wearing a Pit Crew wristband, will be removed from the area, and directed to the Race Secretaries office at the bottom of the Control Tower to obtain one. There will be **NO** exceptions.

### 15. TARGETED SCRUTINY

Scrutiny at this event will be undertaken under the Motorsport Australia Targeted Scrutiny process.

15.1 All vehicles must comply with the relevant requirements for their category. The Chief Scrutineer for the Event will determine which vehicles will be audited and those Competitors will be advised of a time in which the audit will occur at Event Documentation Scrutiny. A Motorsport Australia Vehicle Log Book must be presented. Competitors and Drivers must comply with the Motorsport Australia requirements at the time of entry.

All Competitors must wear apparel in compliance with Schedule D of the Motorsport Australia Manual.

### 16. FUEL

98Ron, Elf Race 102 and commercial E85 fuel are available via bowser at all times. The maximum amount of fuel to be stored in each Garage is 250 litres.

16.2 For all categories, refuelling is not allowed in Pit Lane or in Pit Garages whilst participating in a race or session. Any refuelling done outside this period, must be done in the following manner;

- Both garage doors must be open.
- No open flame or ANY type of cigarette can be present.
- A fire extinguisher must be present under the control of a person appropriately dressed for the function. It fully covered in neck/ankle in non-flammable/flame retardant material.

### 17. INSURANCE

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia. Further details can be found in the Motorsport Australia Insurance Handbook, available at [www.motorsport.org.au](http://www.motorsport.org.au).

### 18. PROTESTS

Protests must be lodged in accordance with of the NCR.

### 19. INTEGRITY

Smoking (including e-cigarettes and vaping) and any naked flame is prohibited within 3 metres of any refuelling or defueling operation.

Motorsport Australia's National Integrity Framework and relevant Policies, including the Australian Anti-Doping Policy, Illicit Drugs in Sport (Safety Testing) Policy and the Alcohol Policy, apply to any activity sanctioned by Motorsport Australia.

Any participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.

Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.
